Terms and Conditions

1. In these conditions:
 - a. *Seller* means Gourmet Only Foods
 - b. *Buyer* means the business to which this Credit Application relates
 - c. *Goods* means all goods to be supplied by the *Seller* to the *Buyer*.
2. Gourmet Only foods retains the right to alter the price of it's products at any time without prior notice.
3. Payment for *Goods* shall be made 14 days from invoice.
4. No claim in respect of *Goods* will be recognized by the *Seller* unless made in writing within 5 standard working days.
5. If the *Buyer* or its agent takes delivery of *Goods* from the *Seller* such acceptance shall constitute confirmation of *Buyer's* acceptance of *Seller's* offer in accordance with these terms and conditions.
6. It is a condition of sale that ownership of goods does not pass to the *Buyer* until the *Seller* receives payment in full.

Declaration

Privacy Act Consent: If the *Seller* considers it relevant to assessing the *Buyer's* application for commercial credit, the *Buyer* agrees to the *Seller* obtaining from a credit reporting agency, a credit report containing personal credit information about the *Buyer* in relation to commercial credit provided by the *Seller*.

If the *Seller* considers it relevant to collecting overdue payments in respect of commercial credit provided to the *Buyer*, the *Buyer* agrees to the *Seller* receiving from a credit reporting agency a credit report containing personal information about the *Buyer* in relation to collecting overdue payments.

The *Buyer* agrees that the *Seller* may give to and seek from any credit providers named in this credit application and any credit providers that may be named in a credit report issued by a reporting agency information about the *Buyer's* credit arrangements. The *Buyer* understands that this information can include any information about his/her credit worthiness, credit standing, credit history or credit capacity that credit providers are allowed to give and receive from each other under the Privacy Act.
